



## SNOW SPORT RELEASE AGREEMENT

**This agreement must be signed and dated and turned in to the office at Sisters Park & Recreation District prior to January 15.**

I recognize that skiing/snowboarding is a hazardous sport that can result in serious injury. I accept the risks inherent in skiing/snowboarding and in the ski area and mountain environment and the transportation thereto. I agree to release, hold harmless, and indemnify Hoodoo Ski Bowl Developers, Inc. d.b.a. Hoodoo Ski Area and its employees, agents, contractors, officers, or owners, or, Sisters Park and Recreation District (SPRD) and its directors, officers, agents and employees, from any cause which arises out of participation in, or travel to and from the Sisters Park and Recreation District Center. This release includes claims based upon negligence but does not apply to claims based upon willful or intentional misconduct. This indemnity agreement includes costs and attorney's fees incurred by Hoodoo Ski Area and Sisters Park and Recreation District, and is binding upon heirs, my assigns, legal representative and me.

If I am signing on behalf of a minor, I accept full responsibility of all medical expenses incurred as a result of the minor's participation in the Hoodoo/Sisters Park & Recreation District Snow sport program. I agree to release, hand indemnify Hoodoo Ski Area and Sisters Park and Recreation District for any claims brought by or on behalf of the minor including all damages, costs and attorney's fees incurred by Hoodoo or Sisters Park and Recreation District.

## TEEN CONDUCT EXPECTATIONS

Teens will arrive on time at the Sisters Park and Recreation District for all programs and will be on time to the bus in order to return home.

Teens will be responsible for their equipment which includes loading and unloading the bus, or caring for their rental equipment.

Teens will remain respectful at all times. This includes respecting the adult chaperones, the bus driver, Hoodoo employees, and other teens.

Disrespectful or foul language will not be tolerated.

Bullying will not be tolerated. Any participant engaging in such behavior will be removed from the program immediately. They may be banned from registering for further snow sport programs through SPRD.

Smoking, alcohol or drug use will not be tolerated. Engaging in such activity will result in the immediate removal from all snow sport programs. Further, if the teen's behavior is deemed illegal, the proper authorities will be contacted.

No registration fees will be refunded to teens removed from programs due to policy violations.

### **The following have been established by the Sisters School District as bus policies.**

Teens are under the authority of the bus driver when on the bus.

Fighting, wrestling or boisterous activity is prohibited on the bus

Firearms, weapons, flammable, or other potentially hazardous materials shall not be brought on the bus.

Teens shall converse in normal tones; loud or vulgar language is prohibited

Teens shall keep the bus clean and refrain from damaging it

Teens refusing to obey promptly to the direction of the driver or other adult chaperones, may forfeit their privilege to take part in snow sport activities

Teens will remove all of their belongings and garbage from the bus. Items on the buses will be placed in lost and found at SPRD.

***I have read and understand the above policies. I understand that my failure to follow these policies may result in my being removed from the program.***
