President Keefer called the meeting to order at 4:30 p.m.

Treasurer Tehan moved to accept the consent calendar as presented. Secretary Vasquez seconded the motion. Motion carried unanimously.

Regarding the general fund, President Keefer asked if the remaining liability will be reduced each month. Operations Manager Hyatt confirmed it will.

President Keefer asked where the \$20,000 worth of grants came from. Director Holland expressed that \$15,000 came from Better Together and \$5,000 came from the Central Oregon Health Council.

Vice President Tryens questioned the amount of money spent on balls for recreation expenses. Director Holland explained that in order to remain COVID compliant, each child had to be given their own individual ball. Each ball also had to be properly disinfected to comply with regulations. It was a quite costly process that the district has never had to implement before.

Treasurer Tehan inquired about materials and supplies incurred for the month of December. She asked, of the \$75,000, what had already been reimbursed? Operations Manager Hyatt explained that not everything was COVID reimbursable, but she would need to go back to the books to give her an exact number. Director Holland explained that SPRD has kept all receipts and tracking expenses to submit in the event more COVID grant money becomes available. She assured the Board that the district would be extremely conservative moving forward.

Vice President Tryens asked if Director Holland had any intelligence from SDAO whether the "big Biden package" would include enough local government money to allow SPRD to be a part of it again. Director Holland explained that she had no information on that specific topic but does have an SDAO meeting coming up where she may or may not be informed on the matter. She asked President Keefer if he had heard anything. President Keefer commented he just knew that Biden wanted to support local governments in the package but there was an upcoming SDAO meeting that he would sit in on if he got the chance.

Treasurer Tehan expressed that on the balance sheet, it shows there is over \$768,000 in the district's account. She wanted to point out that this is the most money the district will have in the account during the year and it will progressively decrease as time goes on.

Regarding the cash flow analysis, Director Holland expressed that Operations Manager Hyatt used conservative numbers and, as it stands, the numbers listed are a worst-case scenario. The district anticipates continuing programs and bringing in more revenue. Operations Manager Hyatt also explained that she and Director Holland ran a calculation for the coming months. Even if all programming were canceled over the next 12 months, with the money the district has in their account, they would remain in good standing.

Board Member Foott asked why SPRD is paying for flood insurance. Director Holland said she would inquire about this with the district's insurance agent.

Board Member Foot motioned to approve payment to Special District Insurance Services as presented apart from first looking into the flood insurance. Vice President Tryens seconded the motion. Motion carried unanimously.

Director Holland explained she had heard the same but commented that the lifted restrictions will remain limited. If a gym has 500 sq. ft or more, it can have 6 people total in the building. Less than 500 sq. ft. buildings are allowed to have one-on-one consultations only. Director Holland asserted that though there will be some restrictions lifted, they are still restrictive in nature.

Treasurer Tehan shared that she has joined the age-friendly Sisters Country Committee as a board member. Her hope is for the district to partner with them when transporting Sisters' residents to vaccination sites or simply collaborating to some extent with vaccinating the community.
